



### **Competition Terms and Conditions**

3) SGS Heating and Electrical Ltd reserves the right to cancel or amend the competition or the rules without notice in the event of an event outside of reasonable control. Any changes will be posted either within these terms and conditions and across competition channels.

### **Qualifying Criteria**

4) All entrants must be aged 18 or over and a resident of the United Kingdom. By entering the competition SGS Heating and Electrical assumes that the entrant consents to entering, and has read and agrees to, the competition terms and conditions.

5) By entering the competition entrants, agree to have their name and the event of their nominee published in the event of being selected as competition winner.
